**ORDER**

**Whereas;** Sh. Pramod Bagri (Valmiki) contested the General Election to the Legislative Assembly of Haryana 2019 from 52-Hisar Assembly Constituency, result thereof was declared on 24-10-2019 and as per Section -78 of the Representation of the People Act, 1951, Sh. Pramod Bagri was required to file true copy of the account of his election expenses in the manner required by law before the District Election Officer, Hisar within thirty days from the date of election; and

**Whereas;** Sh. Pramod Bagri (Valmiki) failed to file his account of election expenses as stipulated under the said Section -78 of the said Act before the District Election Officer, Hisar as reported by the District Election Officer, Hisar vide his letter dated 25-11-2019 under Rule 89 of the Conduct of Election Rules, 1961; and

**Whereas;** A Notice dated 10-09-2020 was issued by the Election Commission of India, requiring Sh. Pramod Bagri to submit his accounts before the DEO concerned, in manner within 20 days of the receipt of notice failing which he would be disqualified from contesting elections to either House of Parliament or of the Legislative Assembly or Legislative Council of a State for a period of three years. The said notice was delivered to Sh. Pramod Bagri (Valmiki) on 27-10-2020 through District Election Officer, Hisar; and

**Whereas;** Sh. Pramod Bagri (Valmiki) submitted a representation dated 27-10-2020 to the Commission stating that the documents viz Election Expenses Register, day to day account of election expenses register, Passbook, Aadhar Card, Voter Card documents have been lost and in this regard he has lodged a FIR on 14-11-2019 in

Civil Line Police Station, Hisar and copy of letter endorsed to CEO and DEO concerned; and

**Whereas;** the Commission forwarded the representation of Sh. Pramod Bagri(Valmiki) vide letter dated 11-02-2021 to the DEO, Hisar and requested him to send a action taken report to the Commission; and

**Whereas;** the District Election Officer, Hisar vide supplementary report -dated 30-06-2021 intimated that Sh. Pramod Bagri (Valmiki) had not submitted his account of election expenses till the date of report i.e. even after expiry of 20 days from the date of receiving of notice; and

**Whereas;** the Commission after keeping in view of the supplementary report of District Election Officer, Hisar, other relevant documents and facts mentioned therein disqualified Sh. Pramod Bagri (Valmiki) for a period of three years from the date of the order for being chosen as, and for being, a member of either House of Parliament or of the Legislative Assembly or Legislative Council of a State under Section 10A of the Representation of the People Act, 1951 for failure to lodge his account of election expenses as required under Section -78 of the said Act and the Rules and Orders made thereunder, vide its order No. 76/ECI/ORD/HAR-LA/52/2019/NS-II, dated 18-05-2022; and

**Whereas;** Sh. Pramod Bagri (Valmiki) submitted a representation dated 27.01.2024 to the Commission alongwith the copies of his account of election expenses and bills, and requesting for removal of disqualification imposed upon him under the provisions of Section 10A of the RP Act, 1951 or in the alternative for reduction of such disqualification period to already undergone. He further stated that afterwards, on 26-07-2023, his aforesaid document which were lost have been found by one typist at the District Court Compound, Hisar. In this regard, a police report was also lodged on the same date i.e. 26-07-2023. The Commission forwarded the request of Sh. Pramod Bagri to District Election Officer, Hisar, vide letter dated 6<sup>th</sup> March. 2024 and asked him to send a scrutiny report of the account of election expense submitted by Sh. Bagri. In response to the Commission's letter dated 06-03-2024, the DEO, Hisar, Haryana has given his report stating that the account of election expenses submitted by Sh. Bagri have been found as per the Commission's instructions and he is satisfied with the correctness of accounts; and

**Whereas;** all the facts of the case and the submission made by Sh. Pramod Bagri (Valmiki) vide his applications dated 27.10.2020, 27.01.2024 and 16.04.2024, have been duly considered; and

**Now,** therefore, in view of all the facts, circumstances of the case, recommendations of DEO, Hisar, Haryana and in exercise of the powers under Section-11 of the Representation of the People Act, 1951 delegated in this regard by the Election Commission of India, I hereby order that the disqualification imposed upon Sh. Pramod Bagri (Valmiki) vide Commission's order dated 18-05-2022, under Section-10A of the said Act, be reduced to the period up to 21.04.2024 and the said disqualification shall not be operative with effect from 22.04.2024 onwards. It is further ordered that a copy of this order shall be made available to all the officers concerned.
