Sub:- Allotment of reserved symbols under para 10A of the Election Symbols (Reservation & Allotment) Order, 1968. - **Uttarakhand Kranti Dal** - regarding.

Sir

I am directed to refer to the subject cited and to state that "**Uttarakhand Kranti Dal**" a registered un-recognized party at present but which was a state recognized party in the state of Uttarakhand prior to its de-recognition, having reserved symbol '**Chair**', in that state has requested the Commission for concession under Paragraph 10A of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol '**Chair**' to the candidates being set up by the party at the current general election to the Assembly constituencies going to be held in your State.

The Commission has decided to extend the concession sought by the party under paragraph 10A of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidates set up by "**Uttarakhand Kranti Dal**" at the current general election to the Legislative Assembly of **Uttar Pradesh** from the 50 assembly constituencies mentioned below shall be allotted the symbol '**Chair**'.
