  - c. In the case of the Cash Flow Statement, of the cash flow for the year ended on that date.

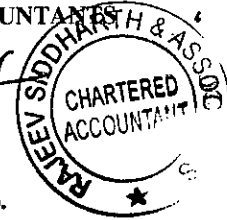
