Note 1

Significant Accounting Policies

1. 'Basis of Preparation:

Provisions are not discounted to its present value and are determined based on best estimates required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimations.

8. Cash Flow Statement:

Cash Flow Statement is prepared as per direct method as referred in AS-3 "Cash Flow Statement".

9. Investments:

No investments have been made during the year.

10. Contingent Liabilities and Contingent Assets:

Contingent Liabilities if material are disclosed by way of notes. Contingent Assets neither recognized nor disclosed in the financial statements.

11. Taxation

No provision for income tax has been considered necessary during the year.
