

The learned Attorney Gereral of India has given an opinion in my favor. He says "It appears this is a civil matter. This was a commercial transaction. There is no material or even allegation that Shri Ranjan obtained any benefit or that there is any mens rea" "He further said" "Making Shri Ranjan an accused was not warranted" and Central Vigilance commission (CVC) has agreed with the opinion of the learned Attorney General by saying that "The commission has agreed with the advise of the Attorney General." 




