

Accordingly, the candidate set up by "Indian Union Muslim League" at the current General Elections to the Legislative Assemblies of Uttar Pradesh for annexed Assembly Constituencies of the said State shall be allotted the symbol 'Ladder'.
- The Returning Officers may be informed that the candidates set up by "Indian Union Muslim League" in the aforesaid Constituencies are eligible for the allotment of the symbol 'Ladder' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
