महोदय,

कृपया उपरोक्त विषयक संदर्भित पत्र का अवलोकन करने का कष्ट करें जिसके साथ भारत निर्वाचन आयोग नई दिल्ली के पत्र संख्या: 76/EE/GE/2014/PPEMS, दिनांक 22.10.2014 की छायाप्रति संलग्न करते हुए सूचित किया गया है कि आयोग के निर्देशानुसार लोक सभा सामान्य निर्वाचन-2014 में राजनैतिक दलों के निर्वाचन व्यय से संबंधित सूचना उपलब्ध कराये जाने की अन्तिम तिथि 26 अगस्त, 2014 समाप्त हो चुकी है, किन्तु उक्त सूचना अधोहस्ताक्षरी द्वारा अभी तक उपलब्ध नहीं करायी गयी है। अतः आयोग के निर्देशानुसार लोक सभा सामान्य निर्वाचन 2014 में "भागीदारी क्रान्ति दल" द्वारा खड़े किये गये अभ्यर्थियों के नामों एवं आय व्यय से सम्बन्धित सूचना निर्धारित प्रारूप पर तथा साफ्ट कॉपी में तत्काल उपलब्ध कराने हेतु अधोहस्ताक्षरी को निर्देशित किया गया है।

उपरोक्त के सम्बन्ध में सादर अवगत कराना है कि "भागीदारी क्रान्ति दल" का पंजीकरण लोकसभा सामान्य निर्वाचन 2014 की अधिसूचना जारी होने के पश्चात भारत निर्वाचन आयोग नई दिल्ली के पत्रांक: फा०सं०: 56/11/2012/रा०द०अनु०-1/1040, दिनांक: 05.05.2014 द्वारा किया गया है। चूंकि दल का पंजीकरण भारत निर्वाचन आयोग नई दिल्ली द्वारा लोकसभा सामान्य निर्वाचन 2014 के लगभग सम्पन्न होने पर किया गया है, इन परिस्थितियों में दल लोकसभा प्रत्याशी उतारने/नामांकन कराने में असमर्थ रहा है।
