Sir

I am directed to invite your attention to the Commission's letter No. 76/EE/2012-21.01.2013, and to state that the political parties for every general election to the House of the People/Legislative Assembly of State/UTs are required to submit their election expenditure statements within the period of 90/75 days after the completion of election. The recognized political parties are required to file the accounts in the prescribed format, with Election Commission, whereas other registered political parties are required to file the accounts with the Chief Electoral Officer of the state, in which the party is having Head Quarters.

The return of election expenses incurred by your party in connection with the Lok Sabha elections has not yet been submitted. The last date for submission of the return has expired on 26<sup>th</sup> August 2014.

You may, therefore, ensure that statements of expenditure are submitted to the Commission in the prescribed format (copy enclosed) with a forwarding letter and a soft copy thereof in CD/Pen Drive at the earliest.

Even if no expenses has been incurred, the political party requires to furnish a "Nil" report in the prescribed format.

Sir,

I am directed to inform that as per the directions of the Hon'ble Supreme Court, in the case of Common Cause v/s. Union of India & Oth. (MR 1996 SC 3081) the Election Commission has prescribed a pro-forma vide its letters dated 27.12.2001, 22.03.2004 and 13.01.2009 in which the political parties are required to submit, for the Commission's scrutiny, the statement of their election expenditure relating to each election to Lok Sabha /State Legislative Assembly. The statement, filed by political parties are put on the website of Commission.

2 I am further directed to inform that a software is being developed by the Commission to process the relevant information in a more systematic and structured manner. Therefore, the Commission has modified the said pro-forma which is enclosed herewith and is also available on its website. The said modified pro-forma provides for furnishing information relating to expenditure at party Central Head Quarters in Part-A, information at State Unit (s) of the party or by State party (including the districts/ Local Units) in Part-B, the summary of the information in part- 'C' and Verification in Part-'D'. The details of expenditure are to be provided in the schedules as per the pro-forma. The modified pro-forma also bifurcates expenditure of political parties for General party propaganda and expenditure attributable to candidates, for better clarity and accountability.


3 The requisite information is sought to enable scrutiny of the expenditure incurred or authorized by the parties or the candidates, set up by them vis-à-vis

exemptions claimed by them in terms of explanation (1) to Section 77(1) of the Representation of the People Act, 1951 in their returns of election expenses, filed under Section 78 of the said Act.

4 I am further directed to inform that the political parties shall file the "Statement of Election Expenditure" in this modified pro-forma for all elections, to be held after 1<sup>st</sup> Jan., 2013 in a hard copy and in soft form on a CD.

5 This may be brought to the notice of all concerned and the receipt of this letter may kindly be acknowledged.
